The copy of deposit slip must be sent to casureco4_bactwg@yahoo.com at least one (1) hour before the start of the Pre-Bid Conference. The bid documents will then be sent in pdf format upon receipt of deposit slip.

The CASURECO BAC shall conduct the meeting for pre-bid and opening of the documents and bid offer at the given address and schedule below Face-to-Face. Authorized attendees, including representatives of bidders are encourage to attend physically at the **CASURECO IV Main Office, TSD Building, Talojongan, Tigaon, Camarines Sur**. Only those who have purchased the Bidding Documents shall be allowed to participate in the Pre-Bid Conference and raise or submit written queries or clarifications.

The respective detailed specifications and quantities shall be discussed and issue during the pre-bid conference. Bidding will be conducted through public bidding procedures using a non-discretionary "pass/fail" criterion for eligibility check, examination, and evaluation of bids, and post-qualification.

Sealed and separate envelopes containing the Eligibility Requirements (Envelope 1) and Bid Proposal (Envelope 2) duly marked as such will be received by the BAC at CASURECO IV TSD Office at the above-specified dates at which time and place the Envelope 1 will be opened first and evaluated. If the submitted documents, Envelope 1 are found eligible, Envelope 2 will be opened and read on the same date and time in the presence of the Bidders or Bidders Representative who choose to attend, otherwise, they will be returned unopened to ineligible bidders.


All bids submitted must be accompanied by a bid security, in cash or manager's check, in the amount equivalent to (2%) of the amount of Approved Budget of the Contract (ABC). The bid security shall be valid for at least 150 days, starting from the date of the bid opening.
